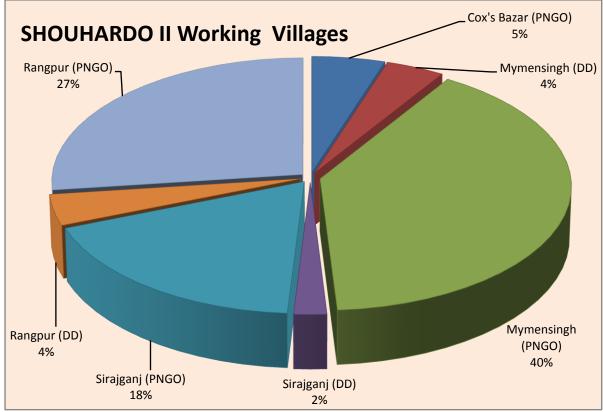

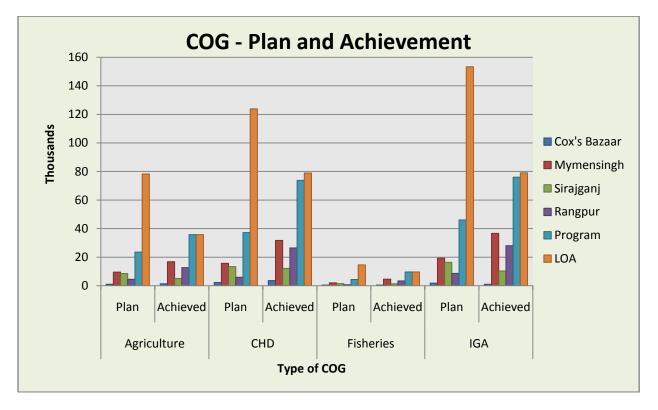

B.2: Number of beneficiary households engaged in different Core Occupational Group (COG) by Regions







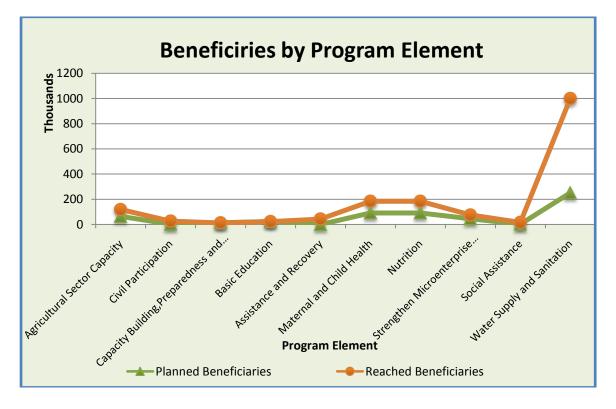
